Privacy Notice

Penistone Footpath Runners & AC is committed to protecting and respecting your privacy. For any personal data you provide for the purposes of your membership, Penistone Footpath Runners & AC is the Data Controller and is responsible for storing and otherwise processing those data in a fair, lawful, secure and transparent way.

What personal data we hold on you

When you register with the club you provide information via on online form. The personal data collected on this form will be kept on the club's membership management system and used for administrative purposes by the club. You will be asked to confirm that you agree to your data and those for any family members linked to your membership being held on the club's membership management system. This information includes your name, date of birth, sex, address, email address, phone numbers, other EA clubs you are a member of and ID numbers for athletics data services.

Why we need your personal data

The reason we need your personal data is to be able to administer your membership, and provide the membership services you are signing up to when you register with the club. Our lawful basis for processing your personal is that we have a contractual obligation to you as a member to provide the services you are registering for.

Reasons we need to process your data include:

- for club coaches or officials to administer training sessions
- to share with leagues, county associations and other competition providers for entry in events
- to communicate with you about club activities, membership, club kit and any other information relating to the club
- processing of membership forms and payments
- · for administering club competitions and publishing of results

On occasion we may collect personal data from non-members (e.g. non-member participants in races or other events organised by the club. This information will be stored for 90 days weeks after an event and then destroyed securely. Our lawful basis for processing data is



consent. Therefore, we will also need explicit consent from non-members to process these data, which we will ask for at the point of collection.

If you join one of the social media groups, please note that provider of the social media platform(s) have their own privacy policies and that the club do not accept any responsibility or liability for these policies. Who we share your personal data with

If you choose to be registered with EA, your name, address, date of birth, sex, email address and phone numbers will be shared with EA. EA will contact you and invite you to sign into the myATHLETICS portal which, amongst other things, allows you to set and amend your privacy settings. If you have any questions about the continuing privacy of your data when they are shared with EA please email dataprotection@englandathletics.org.

Club officers may share your personal data with leagues, county associations and other competition providers for entry into events you choose to participate in.

The Club does not supply any personal data it holds to any other third party,

How long we hold your personal data

We will hold your personal data on file for as long as you are a member with us. Athlete data is updated every year on annual membership forms. Any personal data we hold on you will be securely destroyed after 4 years of inactivity on that member's account, in line with England Athletics Limited's retention policy. Your data are not processed for any further purposes other than those detailed in this policy.

Your rights regarding your personal data

As a data subject you may have the right at any time to request access to, rectification or erasure of your personal data; to restrict or object to certain kinds of processing of your personal data, including direct marketing; to the portability of your personal data and to complain to the UK's data protection supervisory authority, the Information Commissioner's Office about the processing of your personal data. As a data subject you are not obliged to share your personal data with the Club. However, if you choose not to share your personal data with us we will not be able to register or administer your membership.
